#### License Types:

Portable Fire Extinguisher – PFE  
Pre-Engineered Kitchen – PEK

Pre-Engineered Industrial – PEI  
Engineered Special Hazards – ESP

**Unrestricted** if NAFED or ICC Certified

**Restricted** if certified through a Manufacturer

**NICET** – Level III Special Hazards is sufficient for PEK, PEI, and/or ESP

The Company can only be Licensed for the types of License(s) that their Qualifier can be Licensed for. Each Company must have at least one (1) Qualified Technician, each Technician must be under a Company License.

Company License is \$100.00 for each type, new and \$50.00 for annual renewal on the calendar year

Technician License is \$50.00 for each type, new and \$25.00 for annual renewal on the calendar year

Before applying for a New License, please contact [Certificates@sfm.ga.gov](mailto:Certificates@sfm.ga.gov) for prior approval of previous licensing history. New Company Applicants must have three (3) years prior Licensing.

#### New Company License, Documents Required to be Uploaded

- Georgia Secretary of State Registration, if dba – copy of registration, also
- Liability Insurance Certificate, policy Number, expiration date
- Company Letter, detailing submission
- Name of Hydrostatic Testing Contract or RIN Number

- Printer Proofs of Tags, Collars and Stickers (may be provided later)
- Signature of Company Representative Each Technician License

### **New Technician License, documents to be uploaded**

- Name, personal address, personal cell, and email
- Citizenship Affidavit, notarized
- Front/Back of verifiable ID
- Photo of Technician, shoulders up, in gif or jpg format
- Certification: NAFED, ICC or Manufacturer – per license type
- Continuing Education Units (CEU) – from approved provider, 8 hours per license type, if not in the same Certification year
- Duties to be performed, boxes checked
- Digital signature, in gif or jpg format

**To Renew, on a calendar year basis, opening August 1<sup>st</sup> for the following year, must be in by November 30<sup>th</sup>**

- Log In using the established credentials
- Go to "services" and select "licenses"
- Choose "renew your license" on the left
- Select your license #
- After you complete the renewal go to My Account -> Make a Payment.

This will show you all unpaid licenses and allow you to make one payment for each of your licenses.
